DELEGATED DECISIONS

Period Covered: 31st August – 30th November

Decisions related to the following matters were made under the Council's Scheme of Delegated Powers.

- 1. Decision to get quotes for cutting back the foliage around Simpson Village Hall. Quotes were hard to get, received 2 and decided to pursue the cheaper option.
- 2. Decision to purchase a wreath for Remembrance Day, at a cost of £20.
- 3. Decision to accept a grant from MKCC for £4000 towards the running of warm spaces or other initiatives to help with the cost of living crisis.
- 4. Decision to buy and fit gutter guards for Simpson Village Hall as they keep getting blocked with leaves, at a cost of £45.64.
- 5. Decision to purchase a kettle and henry hoover for Ashland Lakeside, whilst on offer, to receive best value, at a cost of £175.47.
